## A] Formation of Anti-Ragging Committee:

The Antiragging committee was framed by the University Grant Commission by the judgement of Hon'ble Supreme court of India dated 8-5-2009 which have been notified on 4<sup>th</sup> July, 2009 in the gazette of India The UGC has made these regulations mandatory for all universities/ institutions. The UGC regulations have made it mandatory for all students/parents to submit anti – ragging related affidavit to the institutions at the time of admission. Our college has set up this committee in accordance with these orders.

At the beginning of the academic year, Anti-Ragging committee is formed in the college to ensure the discipline in the campus. Anti-ragging committee is responsible to ensure that no incidence of ragging takes place. The committee invigilates and ensures smooth functioning of all students activities as well as monitors the functioning of anti-ragging squad. The committee ensure to provide friendly and conducive environment to the new entrants. Anti-ragging committee takes appropriates decisions and punish those found guilty.

#### B] Objectives of Anti- Ragging committee:

- 1) To bring the notice to the students regarding anti- ragging by publishing it in prospectus of the institution.

- 3) To take affidavit regarding anti-ragging from the student and parents at the time of admission.
