Report of Grievance Redressal Committee of Sangola Taluka Shetkari Shikshan Prasarak Mandal Sanchalit Vigyan College Sangola In the academic year 2018-19 a total of eight complaints were received from students.

- 1) Complaint was made regarding loss of Samsung gold color screen touch 4G phone, the said complaint was frivolous due to non-submission of mobile purchase bill, the complaint was settled.
- 2) In the context of this complaint regarding the cleaning of the class of the History Department, since Mr. Koli Devi is the head of the fourth grade staff, the task of cleaning has been interpreted in strong terms.
- 3) In this a complaint was received regarding the misconduct of Pushpakant Arvind Chandanashive and Prajakta Metkari. The said grievance committee further discussed and disposed of the grievance by writing it down on the condition that there will be no further abuse
- 4) Community complaint received from all students of B.Sc Part Two regarding arrangements for mosquito eradication. The said complaint was discussed in the committee and instructions were given to the cleaning staff to maintain cleanliness by spraying once every month to eliminate mosquitoes.
- 5) A request was received from Shri Ligade Kumari Babar Kumari Gaikwad Kumari Ghadge for giving experience certificate of teaching on lock basis basis in the college.
- 6) Regarding the complaint of the watchmen of Shri Dhananjay Dhondiram Bhajanawale College regarding the indiscipline of the students, the said complaint was discussed in the committee. Made aware to take action.
- 7) A complaint was received regarding the use of mobile phones in the study room by Krishna Bhimrao Waghmode, a student of the college. When the said student used a mobile phone in the study room, the mobile phone was confiscated and returned to him after three days on the condition of not using it.

8) A complaint was received regarding the confiscation of the mobile phone of Deepak Mohan Maske, a student of the college. The said student was confiscated for charging the Micromax A99 company mobile phone with charger in the multipurpose hall and the mobile phone was returned to him on understanding of his misbehaviour.

Report of Anti - Ragging Committee (Year - 2018 - 2019)

A] Formation of Anti-Ragging Committee:

The Antiragging committee was framed by the University Grant Commission by the judgement of Hon'ble Supreme court of India dated 8-5-2009 which have been notified on 4th July, 2009 in the gazette of India The UGC has made these regulations mandatory for all universities/ institutions. The UGC regulations have made it mandatory for all students/parents to submit anti — ragging related affidavit to the institutions at the time of admission. Our college has set up this committee in accordance with these orders.

At the beginning of the academic year, Anti- Ragging committee is formed in the college to ensure the discipline in the campus. Anti-ragging committee is responsible to ensure that no incidence of ragging takes place. The committee invigilates and ensures smooth functioning of all students activities as well as monitors the functioning of anti-ragging squad. The committee ensure to provide friendly and conducive environment to the new entrants. Anti-ragging committee takes appropriates decisions and punish those found guilty.

B] Objectives of Anti- Ragging committee:

- 1) To bring the notice to the students regarding anti- ragging by publishing it in prospectus of the institution.
- 2) To display the anti- ragging regulations on board in the college premises.
- 3) To take affidavit regarding anti- ragging from the student and parents at the time of admission.
- 4) To prohibit ragging within or outside the college campus.
- 5) To punish those who are found indulging in ragging.
- 6) To sensitize students and staff to adopt measures that would prevent ragging.
